- Employment-Related Practices
- Repair and/or Servicing of Autos
- Testing, Tuning, or On-Track Operation

Rated per member subject to a minimum premium

Rated based on number of events and the type of event

EXCESS LIABILITY

\$4,000,000 Each Occurrence

\$4,000,000 Products/Completed Work Hazard Aggregate

\$4,000,000 General Aggregate – **Per Event**

Follows form over the event liability policy.

PARTICIPANT ACCIDENT

Covers Scheduled Race & On-Track Motorsports Events

Accident Medical Expense: \$25,000

- Excess Coverage
- Deductible: \$250
- Initial treatment within 30 days
- Benefit Period: 52 Weeks

Accidental Death & Dismemberment: \$10,000
