

## March 2014 Minutes

The March meeting was called to order at 7:31 p.m. and adjourned at 8:12 p.m. Clark Robeson, our treasurer, reported the current balance as \$4,023.72. Clark reminded members that dues for 2014 are due as the club has not received payment from several members. Dues are \$24 for the year.

Jeremy Schaffer gave an activities update. April 26<sup>th</sup> will be the date for the spring cruise. Napa Auto Parts will be the stopping points along the route. The cruise will run through Elkhorn, Ashland, Wahoo and Gretna.

Amber Brush reported old business as the chili cook off that took place on February 16<sup>th</sup>. 1<sup>st</sup> place went to Diane Storm, 2<sup>nd</sup> to Nicki Swieienga and 3<sup>rd</sup> was a tie between Curt Wagner and Ken Foley. Ken was presented his trophy at the meeting as the club had another award made because of the tie.

Amber gave an update on the new Napa Auto Parts store website for club members. An e-mail was sent out with the user id and password to current members on the roster. On the website members can log in, look up parts, availability and price. Members will receive a discounted price on parts for being part of the club. The website will also have a tool box link that will give fluid levels, belts, torque ratings, etc. on any type of vehicle.
